S1./ Q1.	Apakah BSN Micro/i Disaster Relief Facility (DRF)? / What is BSN Micro/i Disaster Relief Facility (DRF)?
Jawapan:/ Answer:	BSN Micro/i Disaster Relief Facility (DRF) ialah satu kemudahan pembiayaan / pinjaman mikro yang ditawarkan kepada Perusahaan Mikro, Kecil dan Sederhana (PMKS) yang terjejas akibat bencana banjir. / BSN Micro/i Disaster Relief Facility (DRF) is a micro financing / loan facility offered to the Micro, Small, Medium Enterprises (MSMEs) affected by the flood disaster.

Jawapan:/ Answer:	<ol style="list-style-type: none"> Perusahaan mikro (Milikan Tunggal / Perkongsian / Syarikat Sdn. Bhd) yang terjejas akibat bencana banjir dan terletak di daerah yang dikenal pasti oleh Agensi Pengurusan Bencana Negara sebagai kawasan bencana banjir. / Micro enterprises (Sole Proprietorship / Partnership / Private Limited Company) affected by flood disaster located in districts identified by Agensi Pengurusan Bencana Negara as flood disaster areas. Dimiliki oleh warganegara Malaysia. / Malaysian owned business. Bekerja sendiri termasuk profesional (Akauntan, Doktor, Peguam). / Self-employed including professionals (Accountant, Doctor, Lawyer). Perniagaan berdaftar dengan Suruhanjaya Syarikat Malaysia (SSM) / Pihak Berkuasa Tempatan (PBT) / Agensi / Badan Profesional (terpakai hanya untuk profesional) / Business registered with Companies Commission of Malaysia (CCM) / Local Authority (LA) / Professional Body / Agency (for professionals only). Perniagaan telah beroperasi sekurang-kurangnya enam (6) bulan. / Business has been in operation for at least six (6) months.

Jawapan:/ Answer:	Semua jenis sektor perniagaan. / All type of business sectors.

Jawapan:/ Answer:	<ol style="list-style-type: none"> Pembaikan dan/atau penggantian aset perniagaan yang telah rosak akibat bencana banjir. / Repairs and/or replacement of assets for business use which have been damaged by the flood disaster. Modal Kerja. / Working Capital.
S5./ Q5.	Berapakah amaun pembiayaan / pinjaman yang ditawarkan di bawah BSN Micro/i Disaster Relief Facility (DRF)? / How much is the financing / loan amount offered under the BSN Micro/i Disaster Relief Facility (DRF)?
Jawapan:/ Answer:	Di antara RM5,000 hingga RM100,000. / Between RM5,000 up to RM100,000.
S6./ Q6.	Berapa lama tempoh pembiayaan / pinjaman bagi BSN Micro/i Disaster Relief Facility (DRF)? / How long is the financing / loan tenure for BSN Micro/i Disaster Relief Facility (DRF)?
Jawapan:/ Answer:	Sehingga 7 tahun termasuk 6 bulan moratorium (penundaan bayaran) bagi pembayaran ansuran bulanan. / Up to 7 years including 6 months moratorium on the monthly instalment.

	<p>(CCM) / Business License with Local Authority (LA) / Professional body registration and certificate of practice (for professionals only).</p> <ol style="list-style-type: none"> Salinan Kad Pengenalan Pemilik Tunggal / Rakan Kongsi / semua Pengarah / Pemegang Saham / Penjamin (jika berkenaan). / A copy of Identification Card of Sole Proprietor / Partners / all Directors / Shareholders / Guarantors (if any). Surat Pengesahan daripada Pegawai Daerah / JKKK / Laporan Polis berkenaan premis perniagaan yang terjejas. / Confirmation letter from the District Officer / JKKK / Police Report in regard to the affected business premises. Salinan bil elektrik premis perniagaan yang terjejas. / A copy of electricity bill of the affected business premises. Penyata Akaun Bank untuk enam (6) bulan terkini. / Latest six (6) months of Bank Account Statement. Jawapan:/ Answer:	<p>Langkah 1 : Lawati laman sesawang BSN untuk menyemak butiran produk. / Step 1 : Visit BSN website to check on product details.</p> <p>Langkah 2 : Semak dan sediakan dokumen sokongan yang diperlukan. / Step 2 : Check and prepare the required supporting documents.</p> <p>Langkah 3 : Kemukakan permohonan ke Pusat Mikro Kewangan BSN / Cawangan Utama Negeri BSN atau lakukan permohonan secara dalam talian. Pihak BSN akan menghubungi pelanggan dalam tempoh enam (6) hari bekerja selepas menerima dokumen yang lengkap untuk memaklumkan berkenaan status permohonan. / Step 3 : Submit the application to the BSN Micro Finance Centre / BSN State Main Branches or perform the application via online. BSN will contact the customer within six (6) working days after receiving complete documents to update on the status of the application.</p>
