1	Introduction	<p>a) The Digital Street Vendor Grant (Geran Digital Penjaja Madani) is an initiative provided by the Ministry of Finance Malaysia in collaboration with Bank Simpanan Nasional (BSN), Malaysia Digital Economy Corporation Sdn Bhd (MDEC), and the Malaysian Communications and Multimedia Commission (MCMC) to assist street vendors in utilizing digital services in their daily business operations ("Initiative").</p> <p>b) This Initiative is offered to street vendors under the Madani Budget 2025 to access digital services from appointed service providers.</p> <p>c) The Ministry of Finance Malaysia, through BSN, as the disbursing bank, has allocated a sum of RM1,000.00 (Malaysian Ringgit One Thousand) only for each eligible street vendor from the total invoices received from the appointed service providers for the implementation of digitalization processes and other services listed within this Initiative.</p>
2	Amount	The grant amount for each vendor is RM1,000.00 (Malaysian Ringgit One Thousand) only and will be directly paid to the appointed digital service provider.
3	Digital Grant	<p>a) Not eligible for vendors who have already received the Geran Digital PMKS Madani.</p> <p>b) This corresponding grant is limited to one (1) application per vendor.</p>
4	Digital Services	<p><u>Digital Payment / Electronic Point of Sale (e-POS)</u></p> <p>The use of software such as Point-Of-Sale to facilitate the vendor company operations.</p>

		<p>Point of Sale (e-POS) to facilitate the operations of the vendor's company.</p> <p>b) Vendors shall submit their applications through the provided online platform.</p> <p>c) If any provided information is found to be incorrect and/or false, BSN reserves the right to request additional documents from the vendor and/or reject the vendor's application.</p> <p>d) Once the vendor's application is approved, BSN will make payment directly to the service provider in full or in stages, at BSN's discretion.</p> <p>e) The allocation of RM1,000.00 (Malaysian Ringgit One Thousand) is subject to any directives issued by the Ministry of Finance Malaysia from time to time.</p> <p>f) Vendors shall ensure that training modules and other digitalization activities prescribed by the service provider are fully implemented.</p> <p>g) Vendors shall provide proof of activation (Proof of Activation) if requested by BSN at any time.</p> <p>h) Vendors shall ensure that the implementation process of Digital Services funded by this Initiative is carried out in full.</p> <p>i) While participating in this Initiative, the importance of upholding the reputation of the Vendor, BSN, MDEC, MCMC, and the Ministry of Finance must be emphasized.
