S1. / Q1.	Apakah BSN Micro/i Semarak PEDi? / What is BSN Micro/i Semarak PEDi?
Jawapan: / Answer:	BSN Micro/i Semarak PEDi ialah satu kemudahan pembiayaan / pinjaman mikro di bawah inisiatif Program Semarak Niaga Keluarga Malaysia (SemarakNiaga) yang ditawarkan kepada peserta Pusat Ekonomi Digital (PEDi) yang menceburi bidang perniagaan. / BSN Micro/i Semarak PEDi is a micro financing / loan facility under the Semarak Niaga Keluarga Malaysia (SemarakNiaga) Programme which is offered to the Digital Economy Centres participants venturing into the business.
S2. / Q2.	Siapakah yang layak untuk memohon BSN Micro/i Semarak PEDi? / Who is eligible to apply for BSN Micro/i Semarak PEDi?
Jawapan: / Answer:	<ol style="list-style-type: none"> 1. Peserta yang berdaftar dengan PEDi. / Participants who registered with PEDi. 2. Perusahaan mikro dimiliki oleh warganegara Malaysia. / Malaysian owned micro business. 3. Perniagaan berdaftar dengan Suruhanjaya Syarikat Malaysia (SSM) / Pihak Berkuasa Tempatan (PBT). / Business registered with Companies Commission of Malaysia (CCM) / Local Authority (LA). 4. Perniagaan telah beroperasi sekurang-kurangnya 6 bulan. / Business has been in operation for at least 6 months.

S5. / Q5.	Berapakah amaun pembiayaan / pinjaman yang ditawarkan di bawah BSN Micro/i Semarak PEDi? / How much is the financing / loan amount offered under the BSN Micro/i Semarak PEDi?
Jawapan: / Answer:	Amaun pembiayaan / pinjaman adalah hingga RM20,000. / The financing / loan amount is up to RM20,000.
S6. / Q6.	Berapa lama tempoh pembiayaan / pinjaman bagi BSN Micro/i Semarak PEDi? / How long is the financing / loan tenure for BSN Micro/i Semarak PEDi?
Jawapan: / Answer:	Tempoh pembiayaan / pinjaman adalah di antara 1 hingga 5.5 tahun termasuk 6 bulan moratorium (rehat bayaran) bagi pembayaran ansuran bulanan. / The financing / loan tenure is between 1 to 5.5 years including 6 months moratorium on the monthly instalment.
S7. / Q7.	Berapakah kadar keuntungan / faedah bagi BSN Micro/i Semarak PEDi? / How much is the profit / interest rate for BSN Micro/i Semarak PEDi?
Jawapan: / Answer:	4.00% setahun dan tiada caj keuntungan / faedah dikenakan semasa tempoh 6 bulan moratorium. / 4.00% p.a. and no profit / interest charged during the 6 months moratorium period.

Surat pengesahan daripada PEDi mengenai pendaftaran perniagaan. / Confirmation letter from PEDi on business registration. 2. Pelan perniagaan. / Business plan. 3. Sijil Pendaftaran Syarikat dengan Suruhanjaya Syarikat Malaysia (SSM) / Lesen Perniagaan dengan Pihak Berkuasa Tempatan (PBT) yang sah. / A valid Business Registration certificate with Companies Commission of Malaysia (CCM) / Business License with Local Authority (LA). 4. Salinan Kad Pengenalan Pemilik Tunggal / Rakan Kongsi / semua Pengarah / Pemegang Saham / Penjamin (jika berkenaan). / A copy of Identification Card of Proprietor / Partners / all Directors / Shareholders / Guarantors (if any). 5. Penyata Akaun Bank untuk 3 bulan terkini. / Latest 3 months of Bank Account Statement. 6. Salinan bil elektrik dan air premis perniagaan. / A copy of electricity and water bills of the business premises. 7. Lain-lain dokumen sokongan tambahan sekiranya diperlukan oleh pihak Bank. / Any supporting documents as required by the Bank.

S9. / Q9.	Bagaimanakah cara untuk memohon BSN Micro/i Semarak PEDI? / How to apply for this BSN Micro/i Semarak PEDI?
Jawapan: / Answer:	<p>Langkah 1 : Lawati laman sesawang BSN untuk menyemak butiran produk. / Step 1 : Visit BSN website to check on product details.</p> <p>Langkah 2 : Semak dan sediakan dokumen sokongan yang diperlukan. / Step 2 : Check and prepare the required supporting documents.</p> <p>Langkah 3 : Kemukakan permohonan ke Pusat Mikro Kewangan BSN / Cawangan Utama Negeri BSN atau lakukan permohonan secara dalam talian. Pihak BSN akan menghubungi pelanggan dalam tempoh 6 hari bekerja selepas menerima dokumen yang lengkap untuk memaklumkan berkenaan status permohonan. / Step 3 : Submit the application to the BSN Micro Finance Centre / BSN State Main Branches or perform the application via online. BSN will contact the customer within 6 working days after receiving complete documents to update on the status of the application.</p>
